

**VILLAGE OF CHAUVIN  
FEES AND CHARGES BYLAW  
BYLAW # 2024-04**

**A BY-LAW OF THE VILLAGE OF CHAUVIN FOR THE PURPOSE OF  
ESTABLISHING FEES AND CHARGES FOR THE PROVISION OF VARIOUS GOODS  
AND SERVICES.**

**WHEREAS** under the authority of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26 and amendments thereto, the Council has the power to enact for the enforcement of bylaws including the imposition of fines and penalties.

**AND WHEREAS** the Village of Chauvin wishes to establish, in a bylaw, certain fees, charges, fines and penalties.

**NOW THEREFORE** the Council for the Village of Chauvin duly assembled hereby enacts as follows:

**1. GENERAL**

- 1.1 This bylaw shall be known as the "Fees and Charges Bylaw".
- 1.2 That the Schedules included in the Bylaw are as follows:
  - Schedule A - Land Use Fees
  - Schedule B - Utility Disconnect Fees
  - Schedule C - Fire Burning/ Pit/ Fireworks Fees
  - Schedule D - Noise Fees
  - Schedule E - Nuisance/ Unsightly Yard Fees
  - Schedule F - Hawkers and Peddlers Licenses, Penalties and Fees
  - Schedule G- Animal Control Fees and Penalties
  - Schedule H - Off- Highway Vehicles Penalties
  - Lot Prices, Recreational Facilities, Cemetery Fees, and Utility Rates are outside the scope of this Bylaw.
- 1.3 That in the event this Bylaw conflicts with another existing bylaw, this bylaw shall take precedence.
- 1.4 That the rates specified in any of the attached Schedules may be amended from time to time upon the recommendation of the respective department head and shall be approved by resolution of Council.

**2. EFFECTIVE DATE**

- 2.1 This bylaw shall come into full force and effect upon passing of the third and final reading.

Livestock \* in addition to the penalty charge, livestock/poultry must be removed from the Village by owner within 48 hours of the offence. The \$1000.00 fine will be charged daily if the animal/s are not removed from the Village within 48 hours of the initial offence time.
